

PRIVACY STATEMENT

This is the privacy statement of the Circular Food Center (hereinafter referred to as "**Circular Food Center**", "we", "us" or "our"), located in Veghel, Verlengde Noordkade 10-12, 5462 EH and registered with the Chamber of Commerce under the name Stichting Samen Tegen Voedselverspilling with number 73289035. This privacy statement explains how we collect, use, share and protect data in relation to our website <https://www.circularfoodcenter.com> (hereinafter referred to as the "**Website**"). We collect this data when you visit our website via your computer, tablet or mobile phone (hereinafter referred to as "**computer**"). We process personal data in a manner that is consistent with the General Data Protection Regulation (hereinafter referred to as the "**AVG**"), the implementing legislation based on the AVG and other currently applicable privacy legislation.

By visiting our website, you understand and agree to the collection and use of information in accordance with this privacy statement. Our privacy statement applies to all visitors, users and all others who have access to the website (hereinafter referred to as "**users**").

What kind of data do we collect?

We collect the following data that you provide to us:

- A. E-mail address
- B. Name
- C. Telephone number
- D. Address
- E. IP address
- F. Communication between Samen Tegen Voedselverspilling and you (we may send you service-related emails)
- G. Communication between the Circular Food Center and you (we may send you service-related emails)
- H. Cookies for the functioning of analytical services and the multilingual function on the website

Log information

When you visit our website, we only collect information that your browser sends when this is necessary for the proper functioning of the website. By the proper functioning of the website we mean in particular the protection of the website against actions that could endanger the security of the website and your computer. This log file may contain information such as your IP address, browser type, browser version, the website pages you visit, time and date of your visit, the time you spend on pages and other statistics.

Analytical services and cookie statement

We use third-party analytical services. These help us to measure our website traffic and trends. The tools collect information sent by your computer, our website, the web pages you visit, add-ons and other information that helps us improve our website. These tools use "cookies". These are simple text files that are stored on your hard disk or in the memory of your computer. Cookies cannot damage your computer or the files on your computer. Cookies collect information anonymously about your log-in information and log-out behaviour. We use this information with information from other users. This makes it impossible for us to identify you as an individual. We use Google Analytics for our analytical services. Google Analytics installs a permanent cookie in your web browser to identify you. This causes your data to be shared with Google. We only share data with Google that we are permitted to share on the basis of the AVG. You can completely prevent Google Analytics from identifying you by deactivating the cookies in your browser.

WPML: WPML is a plug-in for WordPress provided by OnTheGoSystems. We use WPML to make the website available in multiple languages. This plug-in only uses cookies that are necessary for the multilingual functionality and to recognise the preferred language of users of the website.

Circular Food Center uses remarketing services to advertise on third-party websites after you visit our website. We and third parties we work with use cookies to optimize the ads shown to you based on your previous visits. We use the following remarketing services with your permission:

Google: Google AdWords remarketing service is provided by Google Inc. We only use Google AdWords remarketing service at the time you give us permission to do so. You can deactivate Google AdWords remarketing afterwards by withdrawing your consent. You can withdraw consent for Google AdWords at the same place where you consented to the placing of the cookies required for Google AdWords remarketing.

How do we use this information?

We use all the information we collect to support and improve our website by:

- a) Remembering data so that you do not have to log in again each time you visit the website;
- b) Determine, improve, test and review the effectiveness of our website;
- c) View statistics, such as the number of visitors and traffic to the website;
- d) Fix or diagnose technical problems;
- e) Achieve a functional multilingual website.

How is this information shared?

The information shared with the Circular Food Center is under the management of the foundation Samen Tegen Voedselverspilling and is shared with them for the

purpose of service and proper functionality of the Circular Food Center website. We will never rent or sell your (personal) data to third parties.

Change of control

When the Circular Food Center, or part of it, is transferred or one of our assets becomes part of another organisation (for example, as a result of a merger or dissolution), data collected through the website may be part of the transferred assets. The transferee will have to follow the agreements in this privacy statement.

Legal request and damage prevention

Under Dutch law, we have the right to access your information and to retain and/or share it in response to a legal request (such as a search warrant, court order or subpoena). We also have the right to retain and/or share your information if we believe it is necessary to detect, prevent, and address fraud or other illegal activity and to protect ourselves, you, and others. Information we receive about you may be accessed, edited and retained for an extended period when necessary due to a legal request or obligation, an investigation regarding our terms, policies or to otherwise prevent harm.

Samen Tegen Voedselverspilling and the Circular Food Center have taken appropriate technical and organizational measures to protect your data from loss or any form of unlawful acquisition and processing. We use security measures to ensure that information via the website is protected. However, Samen Tegen Voedselverspilling and the Circular Food Center cannot guarantee that the information on the website will not be accessed, disclosed, altered or destroyed. You are at all times responsible for managing the emails between you and Samen Tegen Voedselverspilling as well as you and the Circular Food Center. We are not responsible for the functionality, privacy or security measures of any other organization.

International transfer

Your information may be transferred and maintained on computers and/or servers located outside the Netherlands and/or the EU, where data protection laws may be different. We make every effort to ensure that even when your personal data is processed outside the EU, it is processed in a legally correct and careful manner.

Storage period

In accordance with the AVG and other relevant legislation, Samen Tegen Voedselverspilling and the Circular Food Center will not retain personal data longer than necessary for the purposes for which they were collected or processed.
